Sub: Ongoing JCA agitation – matter regarding.

In pursuance of the discussion we had with the Hon'ble Revenue Secretary, GOI, on 03-11-2015 and also in view of the concern expressed by him towards the issues pertaining to the 5(five) point Charter of Demands submitted by the JCA, especially addressing the stagnation in the cadre of ITO, the members of the JCA hope that the decisions taken in the said meeting will be implemented by the CBDT in a time-bound manner, as desired by the Hon'ble Revenue Secretary. The direction of the Revenue Secretary for holding the DPCs for the R.Y.s 2014-15, 2015-16 & 2016-17 by 31<sup>st</sup> March, 2016 and promoting the officers who had been promoted as ITO till 2003 will eradicate the stagnation in the cadre of ITO at least to some extent. The positive attitude of the Revenue Secretary, GOI, in other issues also will help the CBDT to redress the grievances of the 97% of the officers and employees of the Department.

In view of the positive decisions of the Revenue Secretary acknowledging the long-pending demands of the JCA and his desire to resolve the same in a time-bound manner, the JCA convened its meeting on 03-11-2015 itself to review the ongoing programme of agitation. It has been decided in the said meeting to suspend the ongoing programme of agitation temporarily for 3(three) weeks from today to pave the way for settlement. We would also request you to direct the local authorities not to exert pressure for the reports of the previous month and also the field offices are to be allowed at least 7(seven) days time from now to submit the reports of this month. We hope that the members of the JCA will have no reason to agitate further and the issues, including the promotion from ITO to ACIT, will be resolved and the decisions taken on 03-11-2015 will be implemented immediately.
